On February 7, 2006, the Securities Administrator of the State of Washington issued Statement of Charges and Notice of Intent to Enter an Order to Cease and Desist, Impose Fines, and Charge Costs, Order Number S-05-152-06-SC01, hereinafter referred to as the "Statement of Charges," against Trivista Development Corporation, Trivista Financial Services, LLC, Dennis Ziegler, Roger Dennis Kimble, Chuck Methvin, and Michael Ward.

Pursuant to the Securities Act of Washington, RCW 21.20, the Securities Division of the Department of Financial Institutions ("Securities Division") and Respondent, Roger Dennis Kimble, do hereby enter into this Consent Order in settlement of the above captioned matter. In the Statement of Charges, the Securities Division made certain allegations and conclusions, set forth under the headings of "Tentative Findings of Facts" and "Conclusions of Law." Respondent Roger Dennis Kimble neither admits nor denies the Tentative Findings of Fact and Conclusions of Law, which are incorporated by reference into this Consent Order.

2 Based upon the foregoing,

3 IT IS AGREED AND ORDERED that Respondent, Roger Dennis Kimble, shall cease and desist  
4 from any violation of RCW 21.20.140, the securities registration section of the Securities Act of  
5 Washington.

6 IT IS FURTHER AGREED AND ORDERED that Respondent, Roger Dennis Kimble, shall cease  
7 and desist from any violation of RCW 21.20.040, the broker-dealer and securities salesperson  
8 registration section of the Securities Act of Washington.

9 IT IS FURTHER AGREED AND ORDERED that Respondent, Roger Dennis Kimble, shall cease  
10 and desist from any violation of RCW 21.20.010, the anti-fraud section of the Securities Act of  
11 Washington.

12 IT IS FURTHER AGREED AND ORDERED that Respondent, Roger Dennis Kimble, shall  
13 continue to cooperate with reasonable requests by the Securities Division in this and any related  
14 investigations by the Securities Administrator of the state of Washington.

15 IT IS FURTHER AGREED AND ORDERED that Respondent, Roger Dennis Kimble, shall pay to  
16 the Securities Division the costs, fees, and other expenses incurred in the investigation of this matter in  
17 the amount of \$1,000 on or before the date of entry of this Consent Order.

18 IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this Consent  
19 Order.

20 IT IS FURTHER AGREED that in consideration of the foregoing, Respondent, Roger Dennis  
21 Kimble, waives his right to a hearing on this matter and to judicial review of this matter pursuant to  
22 RCW 21.20.440 and Chapter 34.05 RCW.
