On August 20, 2007 the Securities Division of the Department of Financial Institutions ("Securities Division") entered a Statement of Charges and Notice of Intent to Enter Order to Cease and Desist; To Impose Fines; To Charge Costs; To Deny Investment Adviser Application; and To Deny Investment Adviser, Investment Adviser Representative, Securities Broker-Dealer, and Securities Salesperson License S-07-044-07-SC01 ("Statement of Charges") against Respondents, EZ Show, Inc., Bernie Day, and Gordon L. Powers. Pursuant to the Securities Act of Washington, ch. 21.20 RCW, and the Franchise Investment Protection Act of Washington, ch. 19.100 RCW, the Securities Division and Respondent, EZ Show, Inc., do hereby enter into this Consent Order in settlement of the matters alleged therein. In the Statement of Charges the Securities Division made certain allegations set forth under the hearings "Tentative Findings of Fact" and "Conclusions of Law". Respondent neither admits nor denies said Tentative Findings of Fact of Conclusions of Law as set forth in said Statement of Charges which are incorporated by reference into this Consent Order.

19	Securities Division the costs, fees, and other expenses incurred in the investigation of this matter in the
20	amount of \$1,000 prior to the entry of this Consent Order.
