INTRODUCTION

On June 5, 2008, the Securities Administrator of the State of Washington entered a Statement of Charges, S-07-220-07-SC01, against Respondents Emerald Coin LLC, Emerald Coin Vending, Inc., and Jason Nelson. On April 24, 2009, the Securities Administrator amended the prior Statement of Charges and issued an Amended Statement of Charges, S-07-220-09-SC03, against Respondents Emerald Coin LLC, Emerald Coin Vending, Inc., and Jason Nelson.

The Securities Division and Respondents, Emerald Coin LLC, Emerald Coin Vending, Inc., and Jason Nelson, do hereby enter into this Consent Order in settlement of the above-captioned matter. The Securities Division made certain allegations and conclusions in the Amended Statement of Charges, set forth under the headings "Tentative Findings of Fact" and "Conclusions of Law." Respondents neither admit nor deny the Findings of Fact and Conclusions of Law as set forth in the Amended Statement of Charges, which are hereby incorporated by reference into this Consent Order.

1 **CONSENT ORDER**

2 Based upon the foregoing and finding it in the public interest:

3 IT IS AGREED AND ORDERED that Respondents, Emerald Coin LLC, Emerald Coin Vending,
4 Inc., and Jason Nelson, and their agents and employees, each shall cease and desist from offering or
5 selling business opportunities in violation of RCW 19.110.050, the registration section of the Business
6 Opportunity Fraud Act of the State of Washington.

7 IT IS FURTHER AGREED AND ORDERED that Respondents, Emerald Coin LLC, Emerald
8 Coin Vending, Inc., and Jason Nelson, and their agents and employees, each shall cease and desist from
9 violating RCW 19.110.120, the unlawful acts section of the Business Opportunity Fraud Act of the State
10 of Washington.

11 IT IS FURTHER AGREED AND ORDERED that Respondents Emerald Coin LLC, Emerald Coin
12 Vending, Inc., and Jason Nelson shall disclose the existence and contents of this Order in any disclosure
13 document approved for use in the State of Washington, such requirement commencing from the date of
14 entry of this Order.

15 IT IS FURTHER AGREED that Respondents Emerald Coin LLC, Emerald Coin Vending, Inc.,
16 and Jason Nelson shall pay the Securities Division the costs and other expenses incurred in the
17 investigation of this matter in the amount of \$1,500 on or before the date of entry of the consent order.

18 IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this Order.

19 IT IS FURTHER AGREED that in consideration of the foregoing, Respondents Emerald Coin
20 LLC, Emerald Coin Vending, Inc., and Jason Nelson each waive their rights to a hearing in this matter
21 and judicial review of this matter pursuant to Chapter 34.05 RCW.
