On December 17, 2010, the Securities Administrator of the State of Washington issued Statement of Charges and Notice of Intent to Issue an Order to Cease and Desist, Impose Fines, and Recover Costs, S-07-294-10-SC01, hereinafter referred to as the "Statement of Charges," against the Respondents National Strategic Investment Corporation; Real Investor Mortgage, Inc.; Starlie, LLC; Charles W. Williams; and Steven M. Hettema. The Securities Division and Charles W. Williams; Real Investor Mortgage, Inc.; and Starlie, LLC do hereby agree to this Consent Order in settlement of the above captioned matter. The Securities Division has, in the Statement of Charges, made certain allegations and conclusions, set forth under the headings "Tentative Findings of Fact" and "Conclusions of Law." Charles W. Williams; Real Investor Mortgage, Inc.; and Starlie, LLC neither admit nor deny the Tentative Findings of Fact and Conclusions of Law, which are hereby incorporated by reference into this Consent Order.

11	Mortgage, Inc.; and Starlie, LLC shall be jointly and severally liable for and shall pay the
12	investigative costs incurred in the investigation of this matter in the amount of \$1,800. The
13	Respondents shall pay \$100 before the entry of this Consent Order, and shall make payments of
14	\$100 per month for seventeen (17) consecutive months. Each payment shall be due by the last
15	day of the month. The first payment shall be due by September 30, 2011.
16	IT IS FURTHER AGREED that if the Respondents Charles W. Williams; Real Investor
17	Mortgage, Inc.; and Starlie, LLC fail to make any monthly payment, the \$1,800 in costs imposed
18	in this Consent Order shall become immediately due and payable, and the Securities Division
19	may seek enforcement of the Consent Order pursuant to RCW 21.20.395.
20	IT IS FURTHER AGREED that the Respondents Charles W. Williams; Real Investor
21	Mortgage, Inc.; and Starlie, LLC enter into this Consent Order freely and voluntarily and with
22	full understanding of its terms and significance.
