The Securities Division has, in the Statement of 13 Charges, made certain allegations and conclusions, set forth under the headings "Tentative 14 Findings of Fact" and "Conclusions of Law." Stevens Coffee Company LLC dba Java Girls tm 15 and Steven McDaniel neither admit nor deny the Tentative Findings of Fact and Conclusions of 16 Law, which are hereby incorporated by reference into this Consent Order. 17 CONSENT ORDER 18 Based upon the foregoing and finding it in the public interest: 19 IT IS AGREED AND ORDERED that Respondents, Stevens Coffee Company LLC dba 20 Java Girls tm and Steven McDaniel, and their agents and employees, shall each cease and desist 21 from offering or selling franchises in violation of RCW 19.100.020, the registration section of
