INTRODUCTION

On December 18, 2009, the Securities Administrator of the State of Washington issued Order Number S-07-574-09-SC01, Statement of Charges and Notice of Intent to Enter an Order to Cease and Desist and to Charge Costs ("Statement of Charges"). The Statement of Charges, together with a Notice of Opportunity to Defend and Opportunity for Hearing ("Notice of Opportunity for Hearing") and an Application for Adjudicative Hearing ("Application for Hearing"), were served on Jason Scott Sant ("Sant") on December 28, 2009. The Notice of Opportunity for Hearing advised Sant that a written application for an administrative hearing on the Statement of Charges must be received within twenty days from the date of receipt of the notice. Sant failed to request an administrative hearing within twenty days of receipt of the Statement of Charges and Notice of Opportunity for Hearing, either on the Application for Hearing provided or otherwise.

The Securities Administrator therefore will adopt as final the Findings of Fact and Conclusions of Law as set forth in the Statement of Charges, which are hereby incorporated by reference, and enter a final order against Sant to cease and desist from violations of the Securities Act and to charge costs.

FINAL ORDER

Based upon the foregoing and finding it in the public interest:

It is hereby ORDERED that Jason Scott Sant, now known as Jim Brick, and his agents and employees, each shall cease and desist from offering or selling securities in any manner in violation of RCW 21.20.140, the securities registration section of the Securities Act of Washington.

It is further ORDERED that Jason Scott Sant, now known as Jim Brick, and his agents and employees, each shall cease and desist from offering or selling securities in any manner in violation of RCW 21.20.040, the securities broker-dealer and securities salesperson registration section of the Securities Act.

It is further ORDERED that Jason Scott Sant, now known as Jim Brick, and his agents and employees, each shall cease and desist from offering or selling securities in any manner in violation of RCW 21.20.010, the anti-fraud section of the Securities Act.

It is further ORDERED that Jason Scott Sant, now known as Jim Brick, shall pay investigative costs of \$3,000 to the Securities Division of the Department of Financial Institutions.
