10 INTRODUCTION

11 On February 25, 2008, the Securities Administrator of the State of Washington issued
12 Statement of Charges, S-08-011-08-SC01, against the Respondents, Corps Investment Group,
13 LLC, Hezekiah Corppetts, Patricia Weis, and Milton Johnson. The Securities Division and
14 Respondent Milton Johnson do hereby agree to this Consent Order in settlement of the above
15 captioned order. The Securities Division has, in the Statement of Charges, made certain
16 allegations and conclusions, set forth under the headings "Tentative Findings of Fact" and
17 "Conclusions of Law". Milton Johnson neither admits nor denies the Tentative Findings of Fact
18 and Conclusions of Law, which are hereby incorporated by reference into this Consent Order.

20 CONSENT ORDER

21 Based upon the foregoing and finding it in public interest:

22 IT IS AGREED AND ORDERED that Respondent, Milton Johnson, shall cease and
23 desist from offering or selling business opportunities in violation of RCW 19.110.050, the
24 registration section of the Business Opportunity Fraud Act of Washington.

1 IT IS FURTHER AGREED AND ORDERED that Respondent, Milton Johnson, shall
2 cease and desist from violating RCW 19.110.120, the anti-fraud section of the Business
3 Opportunity Fraud Act of Washington.

4 IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this
5 Order.

6 IT IS FURTHER AGREED that in consideration of the foregoing Respondent, Milton
7 Johnson, waives his rights to a hearing in this matter and judicial review of this order.
