Pursuant to the Securities Act of Washington, RCW 21.20, the Securities Division of the Department of Financial Institutions (“Securities Division”) and Respondents, Robert Malecki; Homeowner Resources LLC; and Kitsap Private Lending Group LLC; do hereby enter into this CONSENT ORDER in settlement of the above captioned matter. Respondents neither admit nor deny the Findings of Fact and Conclusions of Law as set forth in the Statement of Charges, which are hereby incorporated by reference into this Consent Order.

IT IS AGREED AND ORDERED that Respondents, Robert Malecki; Homeowner Resources LLC; Kitsap Private Lending Group LLC; their agents and employees each shall cease and desist from offering

CONSENT ORDER

1 or selling securities in violation of RCW 21.20.140, the securities registration section of the Securities
2 Act of Washington.

3 IT IS FURTHER AGREED AND ORDERED that Respondents, Robert Malecki; Kitsap Private
4 Lending Group LLC; their agents and employees each shall cease and desist from acting as an
5 unregistered securities broker-dealer or salesperson in violation of RCW 21.20.040, the broker-dealer
6 and securities salesperson registration section of the Securities Act of Washington.

7 IT IS FURTHER AGREED AND ORDERED that Respondents, Robert Malecki; Homeowner
8 Resources LLC; Kitsap Private Lending Group LLC; their agents and employees each shall cease and
9 desist from violating RCW 21.20.010, the anti-fraud section of the Securities Act of Washington.

10 IT IS FURTHER AGREED AND ORDERED that Respondent Robert Malecki shall be liable for
11 and pay costs and other expenses incurred in the investigation of this matter in the amount of four
12 thousand dollars (\$4,000) before the entry of this Consent Order.

13 IT IS FURTHER AGREED that Respondents Robert Malecki; Homeowner Resources LLC; and
14 Kitsap Private Lending Group LLC enter into this Consent Order freely and voluntarily and with full
15 understanding of its terms and significance.

16 IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this Order.

17 IT IS FURTHER AGREED that in consideration of the foregoing Respondents Robert Malecki;
18 Homeowner Resources LLC; and Kitsap Private Lending Group LLC waive their rights to a hearing in this
19 matter and judicial review of this order pursuant to Chapter 34.05 RCW.


