11 INTRODUCTION

12 On November 20, 2009, the Securities Administrator of the State of Washington issued a
13 Statement of Charges and Notice of Intent to Enter Order to Cease and Desist (Order Number S-
14 09-156-09-SC01), hereinafter referred to as the "Statement of Charges" against Spencer Brown,
15 doing business as (dba) Rent-A-Green Box. The Respondent hereby enters into this Consent
16 Order in settlement of the above-captioned matter. The Securities Division made certain
17 allegations and conclusions in the Statement of Charges, set forth under the headings "Tentative
18 Findings of Fact" and "Conclusions of Law." The Respondent neither admits nor denies the
19 Findings of Fact and Conclusions of Law, which are hereby incorporated by reference into this
20 Consent Order.

22 CONSENT ORDER

23 Based upon the foregoing and finding it in the public interest:

24 IT IS AGREED AND ORDERED that Respondent, Spencer Brown, dba Rent-A-Green
25 Box, and his agents and employees, each shall cease and desist from any violation of RCW

5 Rent-A-Green Box, and his agents and employees, each shall cease and desist from any violation
6 of RCW 19.100.080, the disclosure document provision of the Franchise Investment Protection
7 Act of the State of Washington.

9 IT IS FURTHER AGREED AND ORDERED that Respondent, Spencer Brown, dba
10 Rent-A-Green Box, and his agents and employees, each shall cease and desist from any violation
11 of RCW 19.100.170, the anti-fraud provision of the Franchise Investment Protection Act of the
12 State of Washington.

13 IT IS FURTHER AGREED that Respondent, Spencer Brown, dba Rent-A-Green Box,
14 enters into this Consent Order freely and voluntarily and with a full understanding of its terms
15 and significance.

16 IT IS FURTHER AGREED that Respondent, Spencer Brown, dba Rent-A-Green Box,
17 shall reimburse the Securities Division \$625, payable prior to the entry of this Consent Order,
18 for its costs of investigation of this matter.

19 IT IS FURTHER AGREED that Respondent, Spencer Brown, dba Rent-A-Green Box,
20 shall, in consideration of the foregoing, waive his right to a hearing in this matter and judicial
21 review of this Consent Order.
