IT IS FURTHER AGREED AND ORDERED that Respondent Glenn Fulton shall cease and desist from violating RCW 21.20.010, the anti-fraud section of the Securities Act of Washington.

IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this Consent Order.

IT IS FURTHER AGREED that Respondent Glenn Fulton enters into this Consent Order freely and voluntarily and with full understanding of its terms and significance.
