INTRODUCTION

On April 24, 2015, the Securities Administrator of the State of Washington issued Statement of Charges and Notice of Intent to Issue an Order to Cease and Desist, To Impose Fines and Charge Costs, S-14-1531-15-SC01, hereinafter referred to as the "Statement of Charges," against the Respondents Randall L. Harper, a.k.a. Randy Harper and d.b.a. Jackson Hewitt Tax Service and RL Harper, LLC. The Securities Division has, in the Statement of Charges, made certain allegations and conclusions, set forth under the headings "Tentative Findings of Fact" and "Conclusions of Law." Respondents Randall L. Harper, a.k.a. Randy Harper and d.b.a. Jackson Hewitt Tax Service and RL Harper, LLC neither admit nor deny the Findings of Fact and Conclusions of Law which are hereby incorporated by reference into this Consent Order.

CONSENT ORDER

Based upon the foregoing and finding it in the public interest:

IT IS AGREED AND ORDERED that Respondents Randall L. Harper, a.k.a. Randy Harper and d.b.a. Jackson Hewitt Tax Service and RL Harper, LLC, their agents, and employees each shall cease and desist from violating RCW 21.20.010, the anti-fraud section of the Securities Act of Washington.

IT IS AGREED AND ORDERED that Respondent Randall L. Harper, a.k.a. Randy Harper and d.b.a. Jackson Hewitt Tax Service, his agents, and employees each shall cease and desist from violating RCW 21.20.040, the securities salesperson and broker-dealer registration section of the Securities Act of Washington.

IT IS AGREED AND ORDERED that Respondent Respondents Randall L. Harper, a.k.a. Randy Harper and d.b.a. Jackson Hewitt Tax Service and RL Harper, LLC, their agents, and employees each shall cease and desist from violating RCW 21.20.140, the securities registration section of the Securities Act of Washington.

IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this Consent Order.

1 IT IS FURTHER AGREED that Respondents Randall L. Harper, a.k.a. Randy Harper and d.b.a. Jackson
2 Hewitt Tax Service and RL Harper, LLC entered into this Consent Order freely and voluntarily and with a full
3 understanding of its terms and significance.

4 IT IS FURTHER AGREED that in consideration of the foregoing, Respondents Randall L. Harper, a.k.a.
5 Randy Harper and d.b.a. Jackson Hewitt Tax Service and RL Harper, LLC waive their right to a hearing and to
6 judicial review of this matter pursuant to RCW 21.20.440 and Chapter 34.05 RCW.

7 WILLFUL VIOLATION OF THIS ORDER IS A CRIMINAL OFFENSE.
