INTRODUCTION

11 On May 15, 2015, the Securities Administrator of the state of Washington issued a Summary
12 Order to Suspend Registration and Notice of Intent to Revoke Registration, Impose a Fine, and Charge
13 Costs order number S-15-1684-15-TO01 ("Summary Order.") The Summary Order together with a Notice
14 of Opportunity to Defend and Opportunity for Hearing and an Application for Adjudicative Hearing was
15 served on Respondent. Respondent withdrew her investment adviser registration and the Securities
16 Division believes that entry of a Consent Order is in the public interest and is appropriate for the protection
17 of investors. Based on the Findings of Fact and Conclusions of Law set forth in the Summary Order, which
18 are incorporated herein by reference, Respondent and Securities Division agree to the following:

CONSENT ORDER

20 This Consent Order relates only to Judith French Tronsrue's registration as an investment adviser
21 and is not intended to affect her registration as an investment adviser representative for another investment
22 adviser or as a broker-dealer representative.

23 IT IS AGREED and ORDERED that Respondent Judith French Tronsrue will not apply for
24 registration as an investment adviser for ten (10) years from the date of entry of this Consent Order.

25 IT IS FURTHER AGREED that Respondent shall pay a fine of \$1,000 and costs of \$200.

1 IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this Consent
2 Order.

3 IT IS FURTHER AGREED that Respondent enters into this Consent Order freely and voluntarily
4 and with full understanding of its terms and significance.

5 IT IS FURTHER AGREED that in consideration of the foregoing, Respondent withdraws her
6 request for a hearing and waives the right to judicial review of this matter pursuant to RCW 21.20.440 and
7 Chapter 34.05 RCW and the Securities Division vacates Summary Order to Suspend Registration and
8 Notice of Intent to Revoke Registration, Impose a Fine, and Charge Costs order number S-15-1684-15-
9 TO01.

10 **AUTHORITY AND PROCEDURE**

11 This Order is entered pursuant to the provisions of chapter 21.20 RCW and is subject to the
12 provisions of RCW 21.20.120 and Chapter 34.05 RCW. Respondent was notified of the right to an
13 administrative hearing and waived it.
