Respondent Inchins Bamboo Garden Franchising LLC, neither admits nor denies the Findings of Fact or Conclusions of Law as stated below. 10 FINDINGS OF FACT 11 Respondent 12 1. Inchins Bamboo Garden Franchising LLC ("Inchins Franchising"), a Georgia limited liability 13 company engaged in the business of offering and selling Inchins Restaurant franchises, was formed on May 14 30, 2006. 15 **Related Entities** 16 2. Red Chili Wok LLC ("Red Chili Wok") is a Washington limited liability company, formed on October 15, 2005. 17 18

3. Bothell Inchin Inc ("Bothell Inchins") is a Washington corporation, formed on September 19,

## **Washington Franchise Activities**

### **Initial Registration**

- 4. On November 17, 2006, the State of Washington Department of Financial Institutions ("WA DFI") granted a franchise registration permit to Georgia franchisor Inchins Franchising. The permit, effective from November 8, 2006, to November 8, 2007, allowed the franchisor to offer and sell Inchins Restaurant franchises in Washington.
- 5. Inchins Restaurants are full service, casual dining restaurants offering Pan Asian cuisine, soft drinks, alcoholic beverages (optional) and related services under the composite service mark INCHIN'S BAMBOO GARDEN.
- 6. On March 27, 2007, Red Chili Wok signed a franchise agreement with Inchins Franchising regarding the purchase of an Inchins Restaurant franchise.
  - 7. *Y.G.* signed the franchise agreement on behalf of Red Chili Wok, as managing member.

#### **Renewal and Further Franchise Sales**

- 8. Red Chili Wok renewed the franchise agreement for the Redmond location on March 27, 2017.
- 9. Red Chili Wok operated the Inchins Restaurant outlet in Redmond, Washington from March 27, 2007, until May of 2021.
- 10. The Redmond Inchins Restaurant outlet closed when the landlord chose to demolish the building to make way for new development.
- 11. Inchins Franchising terminated the franchise agreement with Red Chili Wok for the Redmond outlet at the time of the restaurant closing.

- 12. On September 17, 2017, Red Chili Wok opened a second Inchins Restaurant outlet in Bellevue, Washington after signing a franchise agreement on April 10, 2017.
  - 13. Presently, Red Chili Wok operates the single Inchins Restaurant outlet.
- 14. On February 2, 2017, Bothell Inchins entered a franchise agreement with Inchins Franchising related to an Inchins Restaurant outlet in Bothell, Washington.
- 15. *S.B.*, identified as President of Bothell Inchins, signed the franchise agreement on behalf of the corporation.
  - 16. *Y.G.* is a governor of both Red Chili Wok and Bothell Inchins.
- 17. Inchins Franchising was not registered to offer or sell franchises in Washington during 2017, so any offer or sale had to be exempt from registration requirements.

## **Current Registration Status**

- 18. On November 18, 2022, Inchins Franchising applied to the WA DFI for the Initial Registration of an Offer and Sale of Franchises. Application materials included a Franchise Disclosure Document and various exhibits.
- 19. On December 12, 2023, WA DFI, noting that Inchins Franchising had disclosed multiple Washington outlets in its application materials, requested the franchisor provide further information about the registration or exemption relied upon for sale of its Washington franchises to Red Chili Wok and Bothell Inchins.
  - 20. Inchins Franchising failed to answer WA DFI's initial comment letter.
- 21. WA DFI followed with a targeted inquiry regarding the 2017 franchise sales—Inchins Franchising answered that *both* sales relied upon the exemption of "an offer or sale of an additional franchise to an existing franchisee of the franchisor for the franchisee's own account that is substantially the same as

the franchise that the franchisee has operated for at least two years at the time of the offer or sale, provided the prior sale to the franchisee was pursuant to a franchise offering that was registered in the state of Washington," RCW 19.100.030(6).

- 22. Red Chili Wok—the franchisee of both the previous Redmond outlet and the present Bellevue outlet, does share one governor, *Y.G.*, with Bothell Inchins.
- 23. However, the franchisees Red Chili Wok and Bothell Inchins are not the same entity and do not have the same associated persons.

Based upon the above Findings of Fact, the following Conclusions of Law are made:

#### **CONCLUSIONS OF LAW**


- 24. The offer or sale of franchises as described above constitutes the offer or sale of a franchise as defined in RCW 19.100.010(6), RCW 19.100.010(12), and RCW 19.100.010(17).
- 25. The offer or sale of the franchise operated by Red Chili Wok—the Bellevue outlet—was exempt from registration under RCW 19.100.030(6).
- 26. The offer or sale of the franchise operated by Bothell Inchins—the Bothell outlet—was in violation of RCW 19.100.020 because no registration for such offer or sale is on file with the Washington Securities Administrator.

### **CONSENT ORDER**

Based upon the foregoing and finding it in the public interest:

IT IS AGREED AND ORDERED that Respondent Inchins Franchising, and its agents and employees, shall each cease and desist from offering or selling franchises in violation of RCW 19.100.020, the registration section of the Franchise Investment Protection Act of the state of Washington.

	IT IS FURTHER AGREED that Respondent Inchins Franchising enters into this Consent Order free			
	and voluntarily and with a full understanding of its terms and significance.			
	IT IS FURTHER AGREED that in consideration of the foregoing, Respondent Inchins Franchising			
	waives its right to a hearing and to judicial review of this matter.
