The Securities Division, Department of Financial Institutions, State of Washington, and respondents Car Wash
Guys International, Inc., Lance Winslow, and its agents and employees do hereby agree to this Consent Order in
settlement of the above captioned matter. The Securities Division has, in SDO-79-99, made certain allegations and
conclusions, set forth under the headings "Tentative Findings of Fact" and "Conclusions of Law" in SDO-77-99,
which are hereby incorporated by reference into this consent order.

ORDER AND CONSENT

The Securities Division, Car Wash Guys International, Inc., and Lance Winslow have agreed upon a basis for

8 Winslow inform any of their current Washington franchisees of the existence and contents of this Order.

9 IT IS THEREFORE AGREED AND ORDERED that Car Wash Guys International, Inc. and Lance
10 Winslow shall inform any of their employees and agents who offer franchises in this State of the existence and
11 contents of this Order.

12 IT IS THEREFORE AGREED that Car Wash Guys International, Inc. and Lance Winslow shall reimburse
13 the Securities Division \$500 for its costs incurred in its investigation of this matter.

14 IT IS THEREFORE AGREED that Car Wash Guys International, Inc. and Lance Winslow waive the right
15 to a hearing in this matter.
