7		Participation in the Industry, Collect Examination Fees, and Impose Monetary Fines
8		("Statement of Charges").
9	В.	The Department served the Statement of Charges on Respondents Burien Escrow
10		Company, Inc., Cyndi A. Orht and Chad K. Orht by certified mail on June 2, 2003.
11	C.	Respondents Burien Escrow Company, Inc., Cyndi A. Orht and Chad K. Orht did
12		not file a request for hearing.
13	D.	The Director issued a Final Order on July 30, 2003.
14	E.	Respondents Burien Escrow Company, Inc., Cyndi A. Orht and Chad K. Orht
15		served on the Department a Petition for Reconsideration of Final Order on August
16		8, 2003.
17	F.	In her Order Denying Petition for Reconsideration and Reaffirmation of Director's
18		Final Order Regarding Burien Escrow Company, inc., Cyndi A. Orht and Chad K.
19		Orht, the Director denied Respondents Burien Escrow Company, Inc., Cyndi A.
20		Orht and Chad K. Orht Petition for Reconsideration and reaffirmed the Director's

2	fully advised in the premises, the Court finds that the parties reached a mutually acceptable
3	resolution of this matter and that the parties agree to the entry of the following order.
4	II. ORDER.
5	IT IS HEREBY ORDERED THAT:
6	A. Petitioners' Petition for Judicial Review of a Final Order of the Washington State
7	Department of Financial Institutions filed on September 5, 2003, pursuant to RCW
8	34.05.530 is DISMISSED WITH PREJUDICE and without assessment of costs to the
9	parties.
10	B. Subject to Sections E and F below, Cyndi A. Ohrt, and Chad K. Ohrt, shall
11	permanently CEASE AND DESIST from any and all escrow activity requiring a
12	license issued pursuant to chapter 18.44 RCW.
13	C. Burien Escrow Company, Inc.'s application for a license to conduct the business of
14	an escrow agent is DENIED;
15	D. Cyndi A. Ohrt's application for a license to act as an Escrow Officer is DENIED;
16	E. Cyndi A. Ohrt is PROHIBITED FROM PARTICIPATION in the conduct of the
17	affairs of any licensed escrow agent, in any manner, to include but not be limited to
18	holding the position of Designated Escrow Officer, escrow officer, officer, director,
19	partner, manager, controlling person, stockholder, employee, or independent contractor
20	of an escrow agent for a period of ten (10) years;
21	F. Chad K. Ohrt is PROHIBITED FROM PARTICIPATION in the conduct of the
22	affairs of any licensed escrow agent, in any manner, to include but not be limited to
23	holding the position of Designated Escrow Officer, escrow officer, officer, director,
24	partner, manager, controlling person, stockholder, employee, or independent contractor
25	of an escrow agent for a period of ten (10) years;
26	

1	G. Burien Escrow Company, Inc., Cyndi A. Ohrt, and Chad K. Ohrt shall be
2	responsible for the maintenance of all books, records, and other information in
3	compliance with the Escrow Agent Registration Act and the rules adopted pursuant
4	thereto. Upon sale of Burien Escrow Company, Inc. to an individual or entity licensed
5	pursuant to RCW 18.44, Cyndi A. Ohrt, and Chad K. Ohrt shall be permitted to
6	transfer all books, records, and other information held in compliance with the Escrow
7	Agent Registration Act provided that the Department receives a written notice detailing
8	the reasonable disposition and handling of the books, records, and other information to
9	ensure their maintenance in compliance with the Escrow Agent Registration Act and
10	the rules adopted pursuant thereto.
