FINAL ORDER

I. DIRECTOR'S CONSIDERATION

A. Procedural History. This matter has come before the Director of the Department of Financial Institutions of the State of Washington (Director) pursuant to RCW 34.05.464. On September 23, 2009, the Director, through Consumer Services Division Director Deborah Bortner, entered a Statement of Charges and Notice of Intention to Enter an Order to Cease and Desist, Revoke License, Impose Fine, and Collect Investigation Fee (Statement of Charges). A copy of the Statement of Charges is attached and incorporated into this order by this reference. The Statement of Charges was accompanied by a cover letter dated September 24, 2009, a Notice of Opportunity to Defend and Opportunity for Hearing, and blank Applications for Adjudicative Hearing for ALG Funding LLC and Mark Silverman. The Department served the Statement of Charges, cover letter dated September 24, 2009, Notice of Opportunity to Defend and Opportunity for Hearing, and blank Applications for Adjudicative Hearing for ALG Funding LLC and Mark Silverman on Respondents on October 7, 2009, by First-Class mail and Federal Express overnight delivery. On October 8, 2009, the documents sent via Federal Express overnight delivery were delivered. The documents sent via First-Class mail were not returned to the Department by the United States Postal Service.

1 Respondents did not request an adjudicative hearing within twenty calendar days after the  
2 Department served them with the Notice of Opportunity to Defend and Opportunity for Hearing, as  
3 provided for in WAC 208-08-050(2).

4 B. Record Presented. The record presented to the Director's designee for her review and  
5 for entry of a final decision included the following:

- 6 1. Statement of Charges;
- 7 2. Cover letter dated September 24, 2009;
- 8 3. Notice of Opportunity to Defend and Opportunity for Hearing; and
- 9 4. Blank Applications for Adjudicative Hearing for ALG Funding LLC and Mark Silverman, with documentation of service.

10 C. Factual Findings and Grounds For Order. Pursuant to RCW 34.05.461, the Director's  
11 designee hereby adopts the Statement of Charges, which is attached hereto.

## 12 II. FINAL ORDER

13 Based upon the foregoing, and the Director's designee having considered the record and  
14 being otherwise fully advised, NOW, THEREFORE:

15 A. IT IS HEREBY ORDERED, That:

- 16 1. Respondents ALG Funding LLC and Mark Silverman cease and desist from  
17 conducting the business of a mortgage broker; and
- 18 2. Respondent ALG Funding LLC's license to conduct the business of a Mortgage  
19 Broker is revoked; and
- 20 3. Respondents ALG Funding LLC and Mark Silverman jointly and severally pay a fine  
21 of \$1,100; and
- 22 4. Respondents ALG Funding LLC and Mark Silverman jointly and severally pay an  
23 investigation fee of \$168.

24 B. Reconsideration. Pursuant to RCW 34.05.470, Respondents have the right to file a  
25 Petition for Reconsideration stating the specific grounds upon which relief is requested. The Petition

1 must be filed in the Office of the Director of the Department of Financial Institutions by courier at 150  
2 Israel Road SW, Tumwater, Washington 98501, or by U.S. Mail at P.O. Box 41200, Olympia,  
3 Washington 98504-1200, within ten (10) days of service of the Final Order upon Respondents. The  
4 Petition for Reconsideration shall not stay the effectiveness of this order nor is a Petition for  
5 Reconsideration a prerequisite for seeking judicial review in this matter.

6 A timely Petition for Reconsideration is deemed denied if, within twenty (20) days from the date  
7 the petition is filed, the agency does not (a) dispose of the petition or (b) serve the parties with a written  
8 notice specifying the date by which it will act on a petition.

9  
10 C. Stay of Order. The Director has determined not to consider a Petition to Stay the  
11 effectiveness of this order. Any such requests should be made in connection with a Petition for Judicial  
12 Review made under chapter 34.05 RCW and RCW 34.05.550.

13 D. Judicial Review. Respondents have the right to petition the superior court for  
14 judicial review of this agency action under the provisions of chapter 34.05 RCW. For the requirements  
15 for filing a Petition for Judicial Review, see RCW 34.05.510 and sections following.

16 E. Non-compliance with Order. If you do not comply with the terms of this order, the  
17 Department may seek its enforcement by the Office of Attorney General to include the collection of the  
18 fines and fees imposed herein.

19 F. Service. For purposes of filing a Petition for Reconsideration or a Petition for  
20 Judicial Review, service is effective upon deposit of this order in the U.S. mail, declaration of service  
21 attached hereto.

**INTRODUCTION**

Pursuant to RCW 19.146.220 and RCW 19.146.223, the Director of the Department of Financial Institutions of the State of Washington (Director) is responsible for the administration of chapter 19.146 RCW, the Mortgage Broker Practices Act (Act)<sup>1</sup>. After having conducted an investigation pursuant to RCW 19.146.235, and based upon the facts available as of the date of this Statement of Charges, the Director, through his designee, Division of Consumer Services Director Deborah Bortner, institutes this proceeding and finds as follows:

**I. FACTUAL ALLEGATIONS**

**1.1 Respondents.**

A. **ALG Funding LLC (Respondent ALG)** was licensed by the Department of Financial Institutions of the State of Washington (Department) to conduct business as a mortgage broker on July 21, 2004, and continues to be licensed to date. Respondent ALG is licensed to conduct the business of a mortgage broker at the following location:

1 the cost of the investigation. The investigation charge will be calculated at the rate of forty-eight dollars (\$48) per  
2 hour that each staff person devoted to the investigation.

3 **IV. NOTICE OF INTENTION TO ENTER ORDER**

4 Respondents' violations of the provisions of chapter 19.146 RCW and chapter 208-660 WAC, as set forth  
5 in the above Factual Allegations, Grounds for Entry of Order, and Authority to Impose Sanctions, constitute a basis  
6 for the entry of an Order under RCW 19.146.220, RCW 19.146.221 and RCW 19.146.223. Therefore, it is the  
7 Director's intention to ORDER that:

- 8 **4.1** Respondents ALG Funding, LLC, and Mark Silverman cease and desist from conducting the business of a  
mortgage broker;
- 9 **4.2** Respondent ALG Funding, LLC's, license to conduct the business of a mortgage broker be revoked;
- 10 **4.3** Respondents ALG Funding, LLC, and Mark Silverman jointly and severally pay a fine which as of the date  
11 of this Statement of Charges totals \$1,100; and
- 12 **4.4** Respondents ALG Funding, LLC, and Mark Silverman jointly and severally pay an investigation fee which  
13 as of the date of this Statement of Charges totals \$168 calculated at \$48 per hour for the three and a half  
(3.5) staff hours devoted to the investigation.
