COMES NOW the Acting Director of the Department of Financial Institutions (Director), through her designee Charles E. Clark, Division Director, Division of Consumer Services, and Planet Home Lending, LLC; (Respondent), and finding that the issues raised in the above-captioned matter may be economically and efficiently settled, agree to the entry of this Consent Order. This Consent Order is entered pursuant to Revised Code of Washington (RCW) 31.04, the Consumer Loan Act (Act), and RCW 34.05.060 of the Administrative Procedure Act, based on the following:

## FINDINGS OF FACT

- On or about October 5, 2010, Respondent obtained a license from the Department of 1.1 Financial Institutions of the State of Washington (Department) to conduct the business of a Consumer Loam Company and continues to be licensed to date.
- On or about August 16, 2012, the Washington Supreme Court held that Mortgage Electronic 1.2 Registrations Systems, Inc. (MERS) was not the "beneficiary" to a Deed of Trust in Washington as defined by RCW 61.24.005(2) if it did not hold the corresponding promissory note. Bain v. Metropolitan Mortgage Group, Inc., 175 Wn.2d 83, 110 (2012). The Bain court further held that "characterizing MERS as the beneficiary has the capacity to deceive...." *Id.* at 117.

It is AGREED that Respondent shall develop a methodology for E. tracking Washington deed of trust documents such that a report of activity may be expeditiously prepared upon request by the Department. The sufficiency of any such methodology shall be determined by the Department's Consumer Services Division, Examinations Unit.

Non-Compliance with Order. It is AGREED that Respondent understands that failure to abide by the terms and conditions of this Consent Order may result in further legal action by the Director. In the event of such legal action, Respondent may be responsible to reimburse the Director for the cost incurred in pursuing such action, including but not limited to, attorney fees.

G. **Voluntarily Entered.** It is AGREED that Respondent has voluntarily entered into this Consent Order, which is effective when signed by the Director's designee.
